




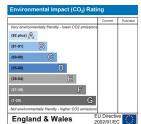
Floor Plan
