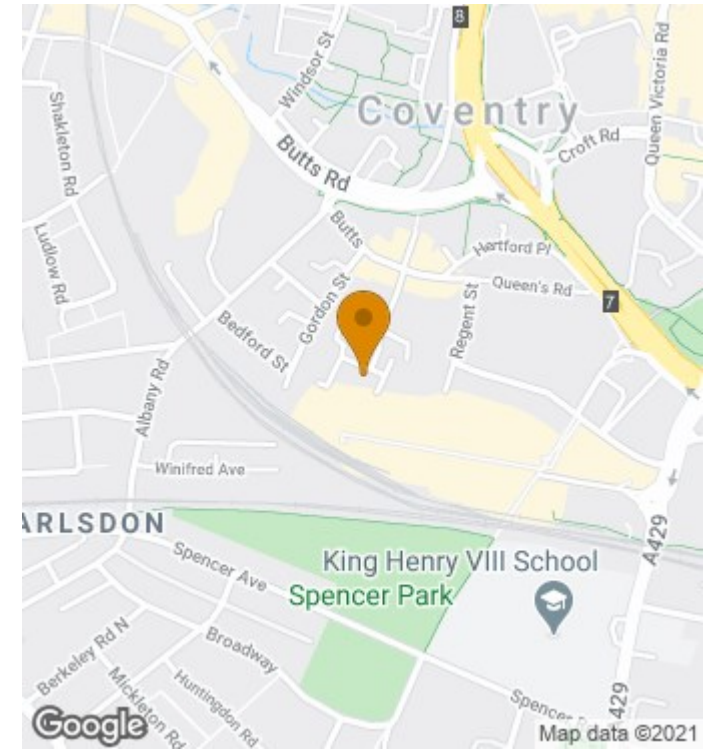


Custom text box

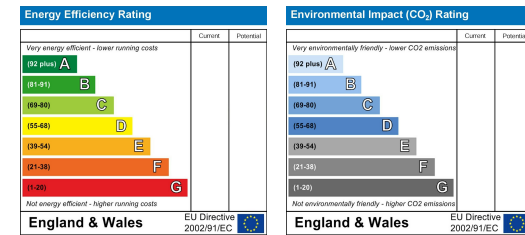
