Description: Bluebells 13 Alexandra Road is a lovely mid terraced 3 bedroomed house split over 3 levels and well appointed to give a cosy but neutral feel. Entering into the hallway on the ground floor there is a kitchen, dining room and sitting room plus access to the rear yard. On the first floor are 2 bedrooms and a bathroom and on the second floor there is the master bedroom with en-suite shower room.

Location: A desirable popular location convenient for the village centre. From Windermere village proceed towards Bowness on Lake Road turning left onto Ellerthwaite Road and then left into Park Avenue. Then take the first turning on the right into Alexandra Road where the property can be found a short way along on the left hand side.

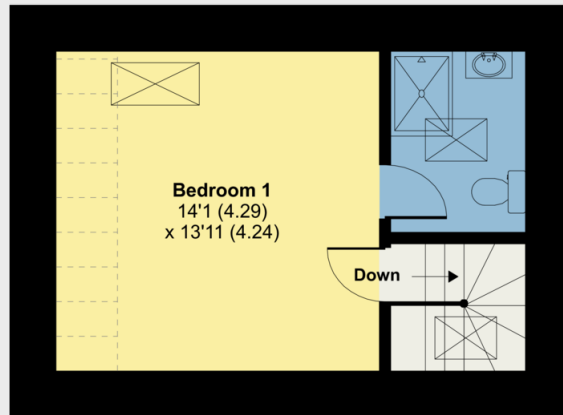

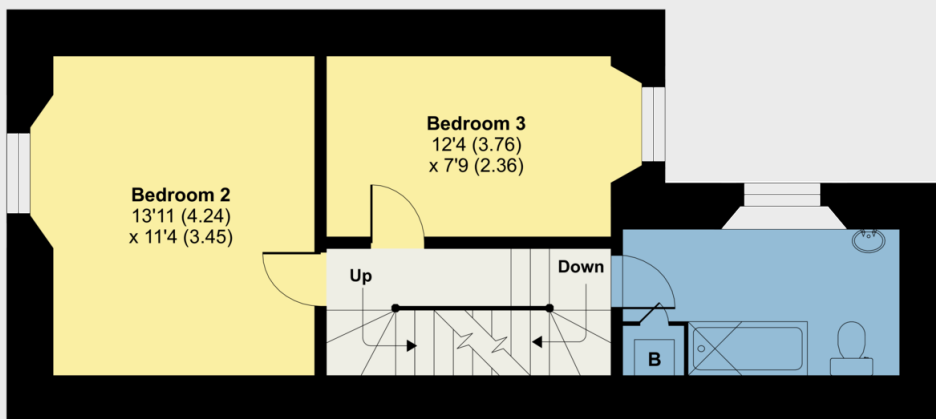

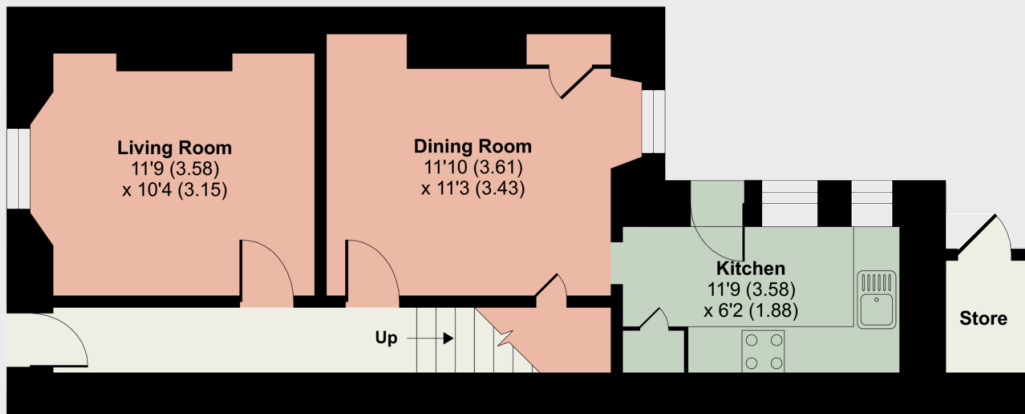
