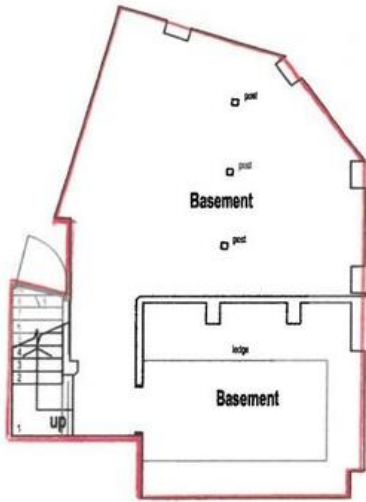

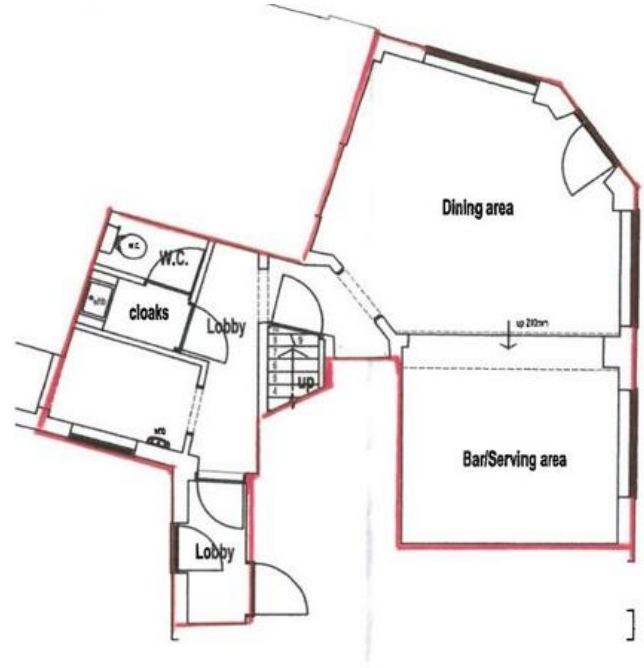

Location

Location The property is located along the busy Rockingham Road which is nearby Sainsburys and has neighbours to include Dominoes, Pizza Hut, RSPCA charity shop and numerous local restaurants and retailers.

Rockingham Road is a busy main road heading North out of Kettering Town Centre.

Description

The property forms part of a two storey end of terrace unit with a first floor office above not included. The unit comprises an open planned area, WCs, Storage and Kitchen facility with additional basement space.

Accommodation

The property has been measured on a net internal basis and is to be measured.

Terms
