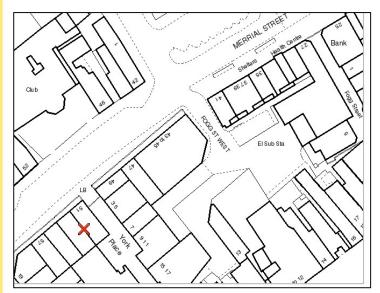

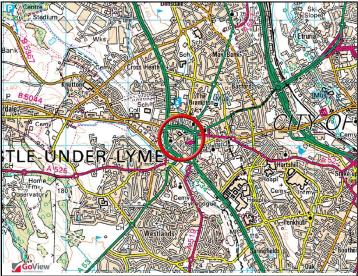

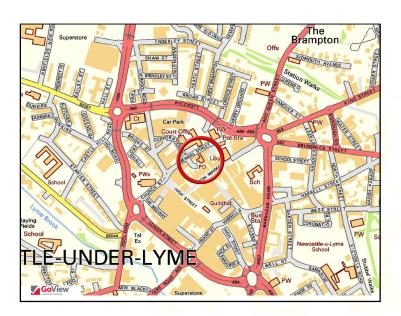
ORDNANCE MAP
