LOUNGE/DINER 18'7" x 16' 2" (5.667m x 4.940m) max measurements. Entrance door, carpet flooring, two radiators, four pendant fittings, loft hatch access, phone intercom system and Danfoss central heating controls. French doors and side panel to the rear aspect, PVC window to the rear and a storage cupboard housing the combination boiler and mains consumer unit plus a light fitting.







KITCHEN 7' 10" x 7' 2" (2.396m x 2.186m) max measurements. Base and eye level units, roll edge work surfaces with tiled splash backs and inset stainless steel sink and drainer. Fitted electric oven, gas hob with extractor over, space and plumbing for a washing machine with further space for a fridge freezer. Vinyl flooring and a spot lit ceiling.

BEDROOM 12' 5" x 11' 4" (3.791m x 3.455m) max measurements. PVC window to the front aspect, carpet flooring, radiator, pendant fitting and storage to the eaves.

BATHROOM 10' 10" x 6' 11" (3.307m x 2.130m) max measurements. Four piece suite comprising of a low level WC, pedestal wash basin, panel bath and mains fed shower cubicle. Vinyl flooring, spot lit ceiling with extractor, heated towel rail, low level wall tiling and a velux window to the front aspect.


ROOF TERRACE Decked area, endosed with lighting.


