**Application for Residency:** Interested parties should complete a Burkitt Homes Almshouse Application Form available from the Agent's offices. There are no application fees payable. All application will be treated in confidence. Applications are subject to the Burkitt Homes Board of Trustees approval at all times. One month's Maintenance Contribution plus any part month due on commencement.

**Residents Handbook:** A copy of the current Residents Handbook with further information on the Burkitt Homes is available for applicants to read prior to making an application.

**Burkitt Homes** is a charity dating from 1909 registered with the Charity Commission registration number 234467 and is run by a Board of volunteer Trustees.
