


LOCATION

Five Mile Lane Industrial Estate is located directly off the B1190 situated close to the villages of Washingborough and Heighington and easily accessible via the recently opened Eastern Bypass (A15) providing excellent connections to Lincoln City Centre and surrounding towns and villages and the National Motorway Network.

ACCOMMODATION

The premises are currently configured to provide a large open-plan showroom/trade area, with customer WC facilities and four dedicated offices off. Beyond this, there are stores and access to the warehouse/workshop facility, which has ancillary staff WC facilities, kitchen and an office together with a mezzanine store above. The floor plan clearly shows the layout/configuration.

The property was originally constructed in 1985 and subsequently extended in 1995 to provide the current configuration.

Externally, the property has the benefit of a large tarmacadam surfaced yard and loading bay together with additional graveled yard space, all enclosed by palisade fencing.

SERVICES

Mains electricity and water are connected. A three-phase power supply is installed and heating is via an oil-fired system. Drainage is to a private treatment plant.


