ENTRANCE HALL

Double glazed French doors leading out to the rear garden, single panelled radiator, tiled floor, door to an under stairs storage cupboard, double glazed window to rear aspect, wide range of re-fitted 'Shaker' style base and eye level units, tall unit housing the stainless steel electric oven and microwave, marble effect square edge work surfaces, integrated slim line dishwasher, stainless steel gas hob with a stainless steel extractor hood above, space for a fridge freezer, attractive tiling to splash back areas.

Double glazed window to rear aspect and a single panelled radiator.

Recessed LED ceiling down lights, column style radiator with a chrome towel rail, low level WC, wash basin with useful storage beneath, traditional style bath with a chrome mixer shower over having a rainfall style shower head, attractive tiled floor and splash back areas.



