LOCATION: -

The property is situated fronting Streatham High Road in a good secondary location just off the prime pitch of the High Road. The property shares the vicinity with a mixture of multiples and more specialist local traders with nearby multiples including KFC, Savers, Carpetright, Nando's and British Heart Foundation. There are nearby short-term parking bays on the High Road together with some parking inside roads. Streatham High Road forms part of the main A23 and the property benefits from vast quantities of passing vehicular traffic and there is a good deal of pedestrian foot flow created by nearby operations. The surrounding area is an extremely densely populated and reasonably affluent catchment.

DESCRIPTION: -

The property comprises a ground floor lock-up shop fronted premises, most recently having formed part of a building society office. The property has a suspended ceiling, air conditioning (not tested), partitioned rear office and a disabled WC. The property is considered suitable for a variety of trades.
