Description

The building is configured as a ground floor and basement retail unit plus two self contained flats.

The flats comprise a studio/1-bed flat at the rear of the ground floor and one 1-bedroom flat on the upper first floor.

The ground floor, which is currently trading as a take-away has a Listed fascia which is actually at the base of the ground floor frontage.

There is the potential for vacant possession of the ground floor take-away unit by further negotiation.

The current income for the three units totals £54,600 per annum, consisting of £33,600 per annum for the residential flats and £21,000 per annum for the retail unit.
