Current available space is situated on the first floor with excellent natural light and is fully fitted for 10 to 12 people

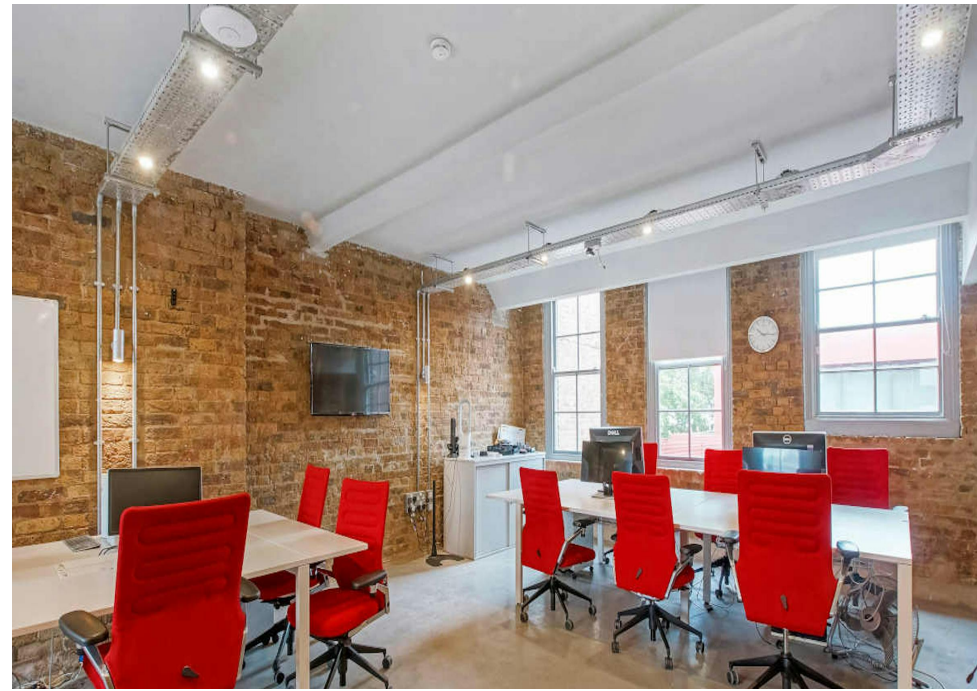
Location

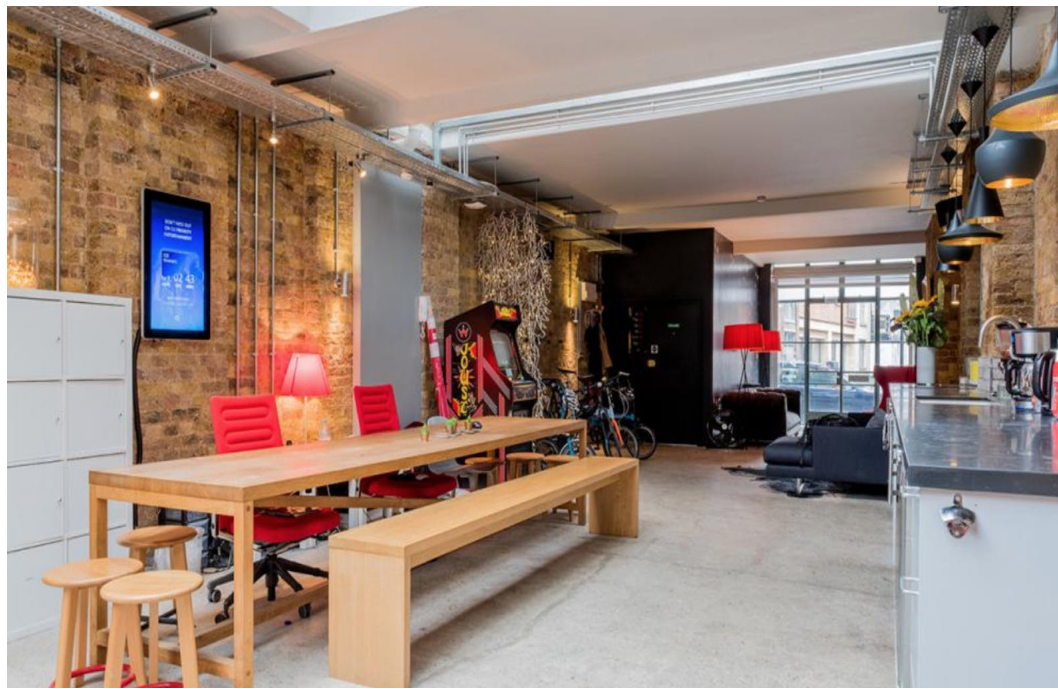

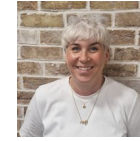
