ACCOMMODATION

A communal entrance door off The Surgery courtyard garden opens into the communal stairwell and on the first floor landing the entrance door opens into the entrance hall with doors to all rooms. The kitchen/breakfast room (14'7" x 8'1" MAX) has light grey base and larder units with oak effect work surfaces incorporating a stainless steel sink/drainage, with space for a fridge/freezer and cooker with an extractor hood over, plumbing for a washing machine and a store cupboard housing the Ideal combi boiler. The living room (17'7" x 14'7") has sash windows, a feature marble fireplace (not in use) and a painted wood panel partition separates it from a double bedroom (14'6" x 13'11") with sash window and a feature marble fireplace (not in use). The second bedroom (14'8" x 9'9" MAX) has fitted cupboards. The shower room (11'3" x 4'7") has a Mira Apt shower in a large cubicle, a pedestal basin, wc, heated towel rail and a cupboard with shelving.
