The Old Exchange is located in the heart of the popular village of Alresford, in close proximity to Winchester with its mainline rail links to London.

The property is accessed via a shared drive on the eastern side of Station Road and is surrounded by a mix of residential and commercial properties.

An abundance of amenities can be found on Alresford High Street, a short 1 minute walk from the property.

Winchester and Junction 9 of the M3 is approximately 6.4 miles to the west accessed via the A31 and the market town of Alton is approximately 11 miles to the east also accessed via the A31.

Terms


Following refurbishment the property is available on a leasehold basis, on terms to be agreed at a quoting rent of £31,400pa (£18.50 per sqft).
