Description

Fairfield house is a modern four storey prominent office building with front access from Kingston Crescent with car park access off Heathfield Road via a security gate. The third floor is to undergo refurbished to a modern standard.

Location

Fairfield House is a modern four storey office building located in the North End area of Portsmouth on Kingston Crescent a short distance from the M275 Rudmore roundabout and the Continental Ferry Port. The property is at the northern fringe of Portsmouth City Centre and 1.5 miles from the M27. Kingston Crescent provides a polarisation of commerce owing to its excellent accessibility by both public and private transport combined with it being situated equidistant from the motorway and prime shopping area. Transport links and retail facilities nearby provide a strong attraction to a workforce. Portsmouth railway station is within 1.5 miles from the property and the Continental Ferry Port is approximately 150 yards away. Commercial Road and the Cascades shopping precinct are approximately 1 mile to the south.
