This large 2 Double Bedroom house is situated in a popular location close to all local amenities and a number of sought after schools.

**ACCOMMODATION:**

Ground Floor: with attractive wood flooring throughout the ground floor, the accommodation comprises Entrance Hall with archway opening to spacious Living Room with bay window and feature fireplace. To the rear of the house there is a lovely open plan Kitchen / Diner with breakfast bar, integrated appliances and ample space for family dining. A large under stairs cupboard provides useful additional storage, while to the rear there is a cloakroom/WC which is currently being refurbished.

First Floor: Carpeted from the stairs up, there is a large principal Bedroom with attractive bay window to the front, with a 2nd Double Bedroom and attractive family Bathroom to the rear which includes a free standing roll top bath and a separate shower cubicle.

**OUTSIDE:**

Low maintenance to both front and rear, there is a decked area immediately outside the dining room ideal for outdoor entertaining.





#### **SITUATION:**

The property is situated in an established residential road close to local shops. The area is generally well favoured with good educational facilities including Southborough Primary School and good secondary/grammar schools in St Johns Road. The larger towns of Tunbridge Wells and Tonbridge are each about 2 miles distant offering a wide range of multiple shopping, leisure and recreational facilities, together with mainline stations providing fast and frequent train services to London Bridge, Charing Cross and Cannon Street. The property is superbly located for access onto the A21 dual carriageway which provides a direct link to the M25 London orbital motorway. Recreational facilities in the area include the Tunbridge Wells Sports & Indoor Tennis Centre in St Johns Road and out of town there is the Knights Park Leisure Centre which provides a tenpin bowling complex, a multiscreen cinema and a private health club.
