GENERAL DESCRIPTION

'Hamil Oatcakes and Snacks' briefly comprises an Oatcake shop and trading business which has been serving the local community and beyond for decades. The current proprietor has owned and operated the business for over twenty years and is now offering the premises and business as a going concern for sale due to retirement. The premises is fully fitted and will be sold with the benefit of all the fixtures and fittings required to operate. Most importantly, the closely guarded recipe required to make the oatcakes will be provided to ensure the popularity of the product and the proprietor is prepared to provide a brief handover period of training once the sale completes to ensure business continuity.

The premises comprises a mid-terrace property with a sales area and counter to the rear of which are the hotplates where food is freshly cooked. Behind the sales area are two further kitchen/food prep rooms and at first floor are two offices/stores. There is also a concrete sectional garage to the rear.

LOCATION

The premises is prominently located on Hamil Road in a densely populated area and within 200 yards of Port Vale Football Club and is approx. a ¼ of a mile to the north of Burslem town centre.

THE BUSINESS

'Hamil Oatcakes and Snacks' is thought to have traded from the same premises for nearly 100 years and the current proprietor took over the business in the late 1990s. The proprietor trades as a 'sole trader' and will sell the business as a going concern together with all the fixtures and fittings and stock at valuation.
