
Prime Shoreditch ground floor retail / showroom or office premises

Comprising a ground and lower ground floor premises of an attractive Victorian warehouse in the heart of Shoreditch. Previously occupied by a hairdressing academy, the ground floor benefits from a valuable period style frontage to Curtain Road which makes the premises suitable for similar occupiers and retailers.

The lower ground floor has natural light, WCs, shower and kitchen and provides open plan work area. The ground floor has excellent floor to ceiling height and provides light bright accommodation, with exposed brickwork and timber flooring.

Situated close to the busy junction of Curtain Road and Great Eastern Street, the location is considered prime Shoreditch being within the Shoreditch triangle and close to the bars, restaurants and cafes that the area is famous for. With an excellent level of footfall during both working hours and evenings / weekends, the spot is ideal for occupiers who will make the most of the passing trade.


