#### Description

The subject premises occupy the ground floor of the former guard house within Portsmouth Naval Base.

The HM Naval Base is situated at the western end of Queen Street and the junction with The Hard. The subject premises are situated inside Victory Gate on the right hand side, within the historic setting of the Naval Dockyard. 
