The property is located in Rectory Gardens a small cul-de-sac of houses on the outskirts of Hartlebury. The property is very well located for easy access to the city of Worcester or out onto the M5 Motorway. The village of Hartlebury provides some local amenities to include a Primary School, Post Office, couple of Public Houses and its own train station making commuting easy with routes to Birmingham and London.

For more extensive leisure and educational amenities, the centre of Worcester is only 10.5 miles away to the south and Stourport on Severn only 2 miles to the west offering the closest supermarket.
