


Location

The Boyd and Rawlings suites are located within the heart of the Gunwharf Quays development in Portsmouth and are within close proximity to the city centre. The offices are easily accessed from Millennium Boulevard, which in turn links to the M275, providing a connection to the M27, A3 and M3 (primary links to London and the south east).

Description

The offices comprise predominantly open plan quality office suites. The suites benefit from fluorescent strip lighting, raised floors, sprinkler system, wet system heating, phone entry and shared WC facilities. The accommodation has a dedicated lobby and lift.

The suites are located on the second floor above the canal side benefiting from full height glazing and high ceilings, which offer stunning views across Gunwharf Quays, by way of a shared balcony.

The Rawlings suite is located immediately ahead of the Emirates Spinnaker Tower.
