# Description

Freehold, part let, mixed use investment for sale, ground floor lock up shop with two bedroom duplex apartment over, garage and close to Worksop town centre.

13 offers ground floor retail accommodation, presently configured to provide an open plan environment plus kitchen and wc facilities, suspended ceilings and central heating. Approx. internal area 46m<sup>2</sup> (405ft<sup>2</sup>). The ground floor is vacant but was last let at £7,000 per annum.

13a delivers two bedroom living space over two floors and is presently let under Assured Shorthold Tenancy terms for a term of 12 months, commencing on 22 April 2022 at £550 per calendar month.

### Location

The property is in a prominent position close to the junction of Gateford Road, Carlton Road, Eastgate and West Western Road, known as Victoria Square. Gateford Road public car park is nearby and surrounding users are typically commercial with many upper floors delivering similar apartments.

Worksop is a North Nottinghamshire market town centrally positioned within easy reach of surrounding centres of Rotherham, Sheffield, Doncaster, Nottingham. The town lies between the A1 to the east and M1 in the west.


