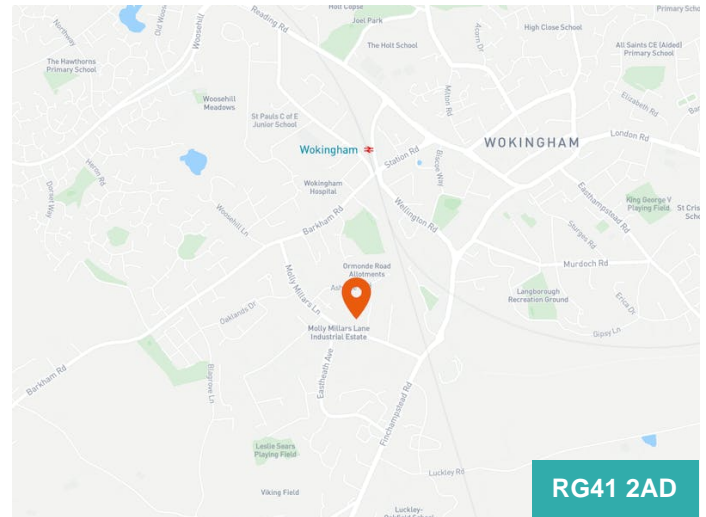
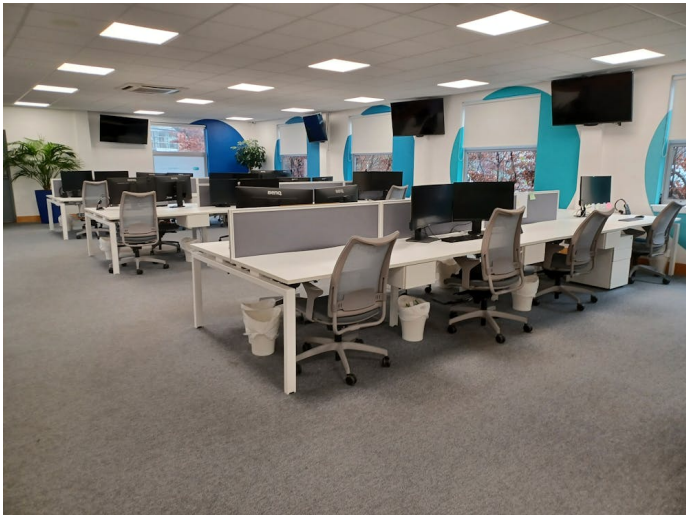

The subject premises is a modern office building with open plan office accommodation over ground and first floors. The building is equipped with WCs, suspended ceilings, raised access floors, air-conditioning, LED lighting and 12 parking spaces.

Location

Millars Brook is located on the northern side of Molly Millars Lane, which is Wokingham's main business area to the south of the town.

Wokingham town centre is within walking distance and provides a wide range of amenities including shops, restaurants, bars, a library, swimming pool and several gyms.

Wokingham Rail Station is within easy walking distance and provides a regular service to Reading (8 minutes) from which connections can be made to London Paddington (26 minutes). There are direct trains from Wokingham to London Waterloo with a journey time of 68 minutes.

Wokingham is also well connected by road, being accessible from M4 J10 via the A329(M) and M3 J3 via the A322.
