Route A Full Electronic Confirmation

Generate an instant electronic ID confirmation report including PEP and Sanctions Check

Route B PEP & Sanctions Check + Photo ID (or authenticated version)

1. PEP & Sanctions Check

An instant electronic PEP & Financial Sanctions check

2. Photo ID or Authenticated Photo ID

Examine a government-issued, original document in presence of the individual, ensuring the photo has a true likeness. e.g. valid passport, photocard driving licence

Upload a copy to the system.

If the person holds valid Photo ID authentication, they can provide you with copies of this which you must retain on file

Route C PEP & Sanctions Check + 2x Non Photo ID (where the individual does not have Photo ID)

1. PEP & Sanctions Check

An instant electronic PEP & Financial Sanctions check

2. 2x Non-photo Documents

Examine two original documents:

A government-issued document confirming full name and address

Secondary documentation confirming address

Upload copies to the system.

Route D Online Biometric Identity verification

1. Send your client an invitation to carry out a full biometric identity and verification check including facial recognition, data verification and document authentication to confirm identity and proof of address.
