## 1. INFORMATION AND SCOPE OF INSPECTION

This section tells you about the type, accommodation, neighbourhood, age and construction of the property. It also tells you about the extent of the inspection and highlights anything that the surveyor could not inspect.

All references to visual inspection refer to an inspection from within the property without the need to move any obstructions and externally from ground level within the site and adjoining public areas. Any references to left or right are taken facing the front of the property.

The inspection is carried out without causing damage to the building or its contents and without endangering the occupiers or the surveyor. Heavy furniture, stored items and insulation are not moved. Unless identified in the report the surveyor will assume that no harmful or hazardous materials or techniques have been used in the construction. The presence or possible consequences of any site contamination will not be researched.

Services such as TV/cable connection, internet connection, swimming pools and other leisure facilities etc. were not inspected or reported on.

**Description** Fairwinds comprises a single storey detached bungalow,

with attached garage and garden ground.

South Ronaldsay is linked to the Orkney mainland by the Churchill Barriers. The full range of amenities are offered in

Kirkwall, which is around 15 miles from the property.

Age The property is thought to date from around 1990.

Weather The weather was cool and bright, following a period of

changeable weather.

**Chimney stacks** There are no chimney stacks.

Visually inspected with the use of binoculars where appropriate.

## Roofing including roof space

Pitched timber framed roof structure, clad with OSB sarking and profiled concrete tiles.

Concrete ventilated ridge and preformed verge pieces. Fibreglass insulation to the ceiling joists.

Sloping roofs were visually inspected with the aid of binoculars where appropriate.

Roof spaces were visually inspected and were entered where there was safe and reasonable access, normally defined as being from a 3m ladder within the property. If this is not possible, then physical access to the roof space may be taken by other means if the Surveyor deems it safe and reasonable to do so.

## Rainwater fittings

uPVC gutters and down pipes.

Visually inspected with the aid of binoculars where appropriate.

#### Main walls

The main walls consist of cavity concrete blockwork.

Dry-dash external finish; smooth render to the ingoes and below DPC level; concrete window cills.

Concrete wall heads with smooth cement render. Stone effect cladding below the windows to the front elevation.

Drill marks suggest that cavity wall insulation may have been installed. However, insulation cannot be seen at tops of gable walls in the roof space.

Visually inspected with the aid of binoculars where appropriate. Foundations and concealed parts were not exposed or inspected.

## Windows, external doors and joinery

Timber double glazed windows; timber single glazed front door; plywood door between the house and the garage.

Internal and external doors were opened and closed where keys were available.

Random windows were opened and closed where possible. Doors and windows were not forced open.

#### **External decorations**

The windows and external doors are painted.

Visually inspected.

## Conservatories / porches

There are no conservatories or porches.

Visually inspected.



### **Communal areas**

There are no communal areas.

Circulation areas visually inspected.

## Garages and permanent outbuildings

There is an integral garage attached to the north end of the house, comprising a concrete floor with inspection pit, block walls, pitched roof clad with tiles, metal roller door, plywood door and timber window.

Internal dimensions 8.7m x 4.4m.

Visually inspected.

## Outside areas and boundaries

The property is surrounded by garden areas, which are mainly laid to grass.

Tarred driveway and gravelled parking area. Block walls and timber fences to the boundaries. Concrete paths around the house; concrete steps to the

## **Ceilings**

The ceilings are lined with plasterboard.

Visually inspected from floor level.

### Internal walls

Interior walls and partitions are timber framed and lined with plasterboard.

Plywood wall linings to the Bathroom.

Visually inspected from floor level.

Using a moisture meter, walls were randomly tested for dampness where considered appropriate.

## Floors including sub floors

Solid concrete ground floor.

Surfaces of exposed floors were visually inspected. No carpets or floor coverings were lifted.



## Internal joinery and kitchen fittings

Fitted floor and wall units to the Kitchen/Dining Room. Softwood 4-panelled interior doors; glazed door & side panel between the Entrance Vestibule and Hall; glazed door between the Hall and Kitchen/Dining Room.

Built-in wardrobes to two Bedrooms with louvred doors; cupboards to the Hall and Kitchen/Dining Room.

Softwood timber skirtings and facings; timber window cills and ingoes.

Built-in cupboards were looked into, but no stored items were moved.

Kitchen units were visually inspected excluding appliances.

## Chimney breasts and fireplaces

There are no chimney breasts or fireplaces.

Visually inspected. No testing of the flues or fittings was carried out.

### Internal decorations

Internal ceilings are emulsioned or finished with textured plaster.

Walls are painted or wallpapered.

Interior woodwork is varnished.

Tiled splashbacks to the Kitchen/Dining Room; tiles to two walls of the Bathroom.

Floor finishes consist of carpet, floor tiles and laminate.

Visually inspected.

## **Cellars**

There are no cellars.

Visually inspected where there was safe and purpose-built access.

## **Electricity**

The property is served by a mains electricity supply to a distribution board and dual tariff meters in a cupboard in the Garage.

Extractor fan to the Kitchen/Dining Room.

Accessible parts of the wiring were visually inspected without removing fittings. No tests whatsoever were carried out to the system or appliances. Visual inspection does not assess any services to make sure they work properly and efficiently and meet modern standards. If any services are turned off, the surveyor will state that in the report and will not turn them on.



### Gas

There is no mains gas in Orkney.

No Calor Gas installation at the property.

Accessible parts of the system were visually inspected without removing fittings. No tests whatsoever were carried out to the system or appliances. Visual inspection does not assess any services to make sure they work properly and efficiently and meet modern standards. If any services are turned off, the surveyor will state that in the report and will not turn them on.

## Water, plumbing and bathroom fittings

There is a mains water supply to the property.

The pipework, where visible, is of copper and uPVC construction.

Sanitary ware includes:

Kitchen/Dining Room: 1.5 bowl composite sink and drainer. Bathroom: bath with timber surround, electric shower with tray and cabinet, wash-hand basin & WC.

Insulated cold water header tank in the roof space.

Visual inspection of the accessible pipework, water tanks, cylinders and fittings without removing any insulation.

No tests whatsoever were carried out to the system or appliances.

## Heating and hot water

The house is heated by Dimplex Quantum high heat retention storage heaters in the Sitting Room, Kitchen/Dining Room and Hall; panel heaters to the Bedrooms; electric towel rail and a wall-mounted fan heater in the Bathroom.

There is an insulated hot water cylinder in a cupboard off the Hall, with a single electric immersion.

Accessible parts of the system were visually inspected apart from communal systems, which were not inspected.

No tests whatsoever were carried out to the system or appliances.

### Drainage

Drainage is understood to connect to a private septic tank on site.

Drainage covers etc were not lifted. Neither drains nor drainage systems were tested.

## Fire, smoke and burglar alarms

Smoke detectors fitted to the ceilings of the Sitting Room and Hall; high heat detector to the Kitchen/Dining Room.

Visually inspected.

No tests whatsoever were carried out to the system or appliances.



## Any additional limits to inspection:

At the time of our inspection the property was occupied and fully furnished with floors fully covered throughout.

Pitched roof coverings were inspected from ground level; a detailed inspection of condition was not undertaken.

An inspection for Japanese Knotweed or other invasive plant species was not carried out.


There was no access for inspection to the foundations or behind wall linings.

The drainage system was not open to inspection.

High levels of Radon gas have been recorded in areas of Orkney. No tests were carried out to detect the levels of gas in the property.





## The energy efficiency rating of your home

Your Energy Efficiency Rating is calculated using the standard UK methodology, RdSAP. This calculates energy used for heating, hot water, lighting and ventilation and then applies fuel costs to that energy use to give an overall rating for your home. The rating is given on a scale of 1 to 100. Other than the cost of fuel for electrical appliances and for cooking, a building with a rating of 100 would cost almost nothing to run.

As we all use our homes in different ways, the energy rating is calculated using standard occupancy assumptions which may be different from the way you use it. The rating also uses national weather information to allow comparison between buildings in different parts of Scotland. However, to make information more relevant to your home, local weather data is used to calculate your energy use, CO<sub>2</sub> emissions, running costs and the savings possible from making improvements.

## The impact of your home on the environment

One of the biggest contributors to global warming is carbon dioxide. The energy we use for heating, lighting and power in our homes produces over a quarter of the UK's carbon dioxide emissions. Different fuels produce different amounts of carbon dioxide for every kilowatt hour (kWh) of energy used. The Environmental Impact Rating of your home is calculated by applying these 'carbon factors' for the fuels you use to your overall energy use.

The calculated emissions for your home are 79 kg CO<sub>2</sub>/m<sup>2</sup>/yr.

The average Scottish household produces about 6 tonnes of carbon dioxide every year. Based on this assessment, heating and lighting this home currently produces approximately 8.2 tonnes of carbon dioxide every year. Adopting recommendations in this report can reduce emissions and protect the environment. If you were to install all of these recommendations this could reduce emissions by 4.2 tonnes per year. 

## About the recommended measures to improve your home's performance rating

This section offers additional information and advice on the recommended improvement measures for your home

### 1 Floor insulation (solid floor)

Insulation of a floor will significantly reduce heat loss; this will improve levels of comfort, reduce energy use and lower fuel bills. Insulating solid floors can present challenges; insulation laid on top of existing solid floors may impact on existing doors and finishes whilst lifting of a solid floor to insert insulation below will require consideration of the potential effect on both structural stability and damp proofing. It is advised to seek advice from a Chartered Structural Engineer or a registered Architect about this if unsure. Further information about floor insulation is available from many sources including www.energysavingtrust.org.uk/scotland/Insulation/Floor-insulation. Building regulations generally apply to this work and may also require a building warrant so it is best to check with your local authority building standards department.

### 2 Solar water heating

A solar water heating panel, usually fixed to the roof, uses the sun to pre-heat the hot water supply. This can significantly reduce the demand on the heating system to provide hot water and hence save fuel and money. Planning permission might be required, building regulations generally apply to this work and a building warrant may be required, so it is best to check these with your local authority. You could be eligible for Renewable Heat Incentive payments which could appreciably increase the savings beyond those shown on your EPC, provided that both the product and the installer are certified by the Microgeneration Certification Scheme (or equivalent). Details of local MCS installers are available at www.microgenerationcertification.org.

### 3 Solar photovoltaic (PV) panels

A solar PV system is one which converts light directly into electricity via panels placed on the roof with no waste and no emissions. This electricity is used throughout the home in the same way as the electricity purchased from an energy supplier. Planning permission might be required, building regulations generally apply to this work and a building warrant may be required, so it is best to check with your local authority. #### PART 1 – GENERAL

#### 1.1 THE SURVEYORS

The Seller has engaged the Surveyors to provide the Single Survey Report. The Seller has also engaged the Surveyors to provide an Energy Report in the format prescribed by the accredited Energy Company.

Once the Seller has conditionally accepted an offer to purchase made in writing, the Purchaser's lender or conveyancer may request that the Surveyors provide general comment on standard appropriate supplementary documentation. #### PART 2 – DESCRIPTION OF THE REPORT

#### 2.1 THE SERVICE

The Single Survey is a Report by an independent Surveyor, prepared in an objective way regarding the condition and value of the Property on the day of the inspection, and who is a member of the Royal Institution of Chartered Surveyors. It includes an Energy Report as required by Statute and this is in the format of the accredited Energy Company.

### 2.2 THE INSPECTION

The Inspection is a general surface examination of those parts of the Property which are accessible: in other words, *visible and readily available for examination from ground and floor levels, without risk of causing damage to the Property or injury to the Surveyor.* 

All references to visual inspection refer to an inspection from within the property at floor level and from ground level within the site and adjoining public areas, without the need to move any obstructions. Any references to left or right are taken facing the front of the property.

The Inspection is carried out with the Seller's permission, without causing damage to the building or contents. Furniture, stored items and insulation are not moved.

In the case of flats, the following further assumptions are made that:

- \*There are rights of access and exit over all communal roadways, corridors, stairways etc and to use communal grounds, parking areas, and other facilities;
- \*There are no particularly troublesome or unusual legal restrictions;
- \*There is no current dispute between the occupiers of the flats or any outstanding claims or losses; and the costs of repairs to the building are shared among the co-proprietors on an equitable basis.

Any additional assumption, or any found not to apply, is reported.

"Re-instatement cost" is an estimate for insurance purposes of the current cost of rebuilding the Property in its present form unless otherwise stated. This includes the cost of rebuilding the garage and permanent outbuildings, site clearance and professional fees, but excludes VAT (except on fees).

Sellers or prospective Purchasers may consider it prudent to instruct a reinspection and revaluation after a period of 12 weeks (or sooner if appropriate) to reflect changing circumstances in the market and/or in the physical condition of the Property.
