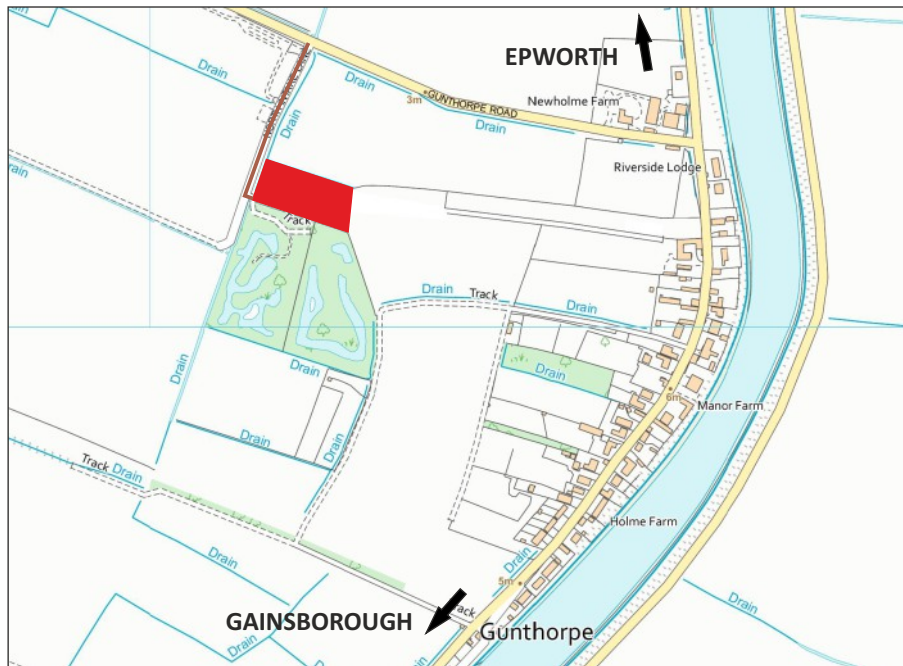

## General Remarks and Stipulations

### Location

The land is situated to the west of the hamlet of Gunthorpe and to the south of Gunthorpe Road. The village of Epworth lies approximately six miles to the north west and the town of Gainsborough lies approximately ten miles to the south.

### Description

The land comprises a single grass field which is accessed via an accommodation track off Gunthorpe Road, as shown brown on the plan.

The land is classified as Grade 1, on Sheet 104 of the Provisional Agricultural Land Classification Maps as historically published by the Ministry of Agriculture, Fisheries and Food.

The soils are identified by the Soil Survey of England and Wales as being from the "Romney" association with their characteristics described as "deep stoneless permeable calcareous coarse and fine silty soils" and as suitable for "sugar beet, potatoes and cereals; some field vegetables and horticultural crops".

### Basic Payment Scheme

The land is registered on the Rural Payments Agency Rural Land register and has been used to activate Basic Payment Scheme entitlements. It is intended that there will be a permanent transfer of Normal Entitlements to the Purchaser(s) for the purpose of the Basic Payment Scheme, as part of the agreed consideration, following completion, if required. The owner made a Basic Payment Scheme claim for the 2022 season. A copy of the 2022 BP5 application form and relevant LPIS map are available for inspection at the Selling Agents office by prior appointment or can be emailed out on request. Purchaser(s) should satisfy themselves as to the accuracy of the same. Any statement within these particulars is given in good faith but carries no warranty.

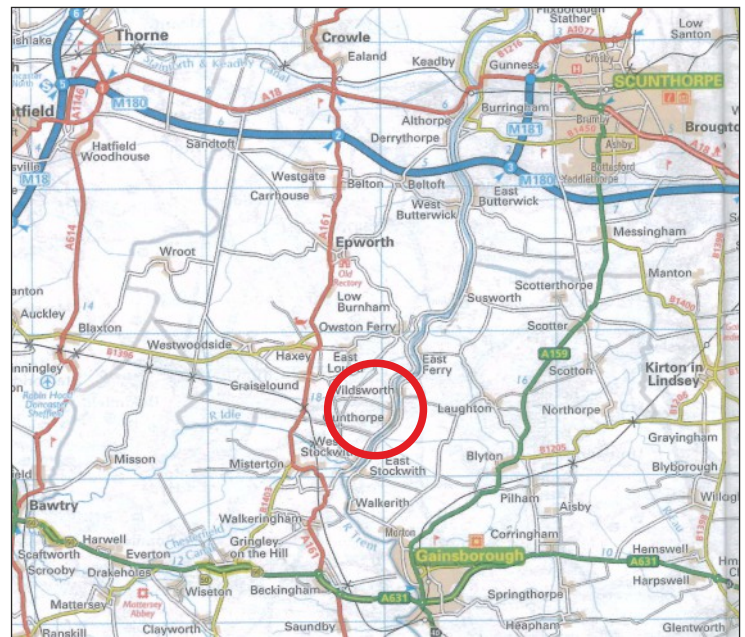
There is a public footpath running along the southern side of the land.
