Attractive period building for rent on the boundary of the City and Shoreditch





Description

The property forms part of a Grade II listed Georgian terrace and offers self-contained accommodation over basement to third floor. The property has recently undergone some light refurbishment to include the installation of a modern kitchen and air conditioning throughout.

The ground and upper floors offer largely open plan offices with good ceiling heights throughout and fantastic natural light, whilst the basement area, which benefits from good natural light, offers a large six to eight person board room.

Location

The building is located on the boundary of the City and Shoreditch. A peaceful street just off Finsbury Square that offers access to a variety of local amenities from the bars and restaurants in Broadgate Circle to the quirky cafes and food outlets in Shoreditch.

The transport links are fantastic with multiple options within walking distance from Liverpool Street and Moorgate Stations offering Mainline, Underground and Elizabeth Line to Shoreditch High Street and Old Street Stations.
