Further Details

Description

Detached industrial building constructed in 1990 comprising a steel portal frame construction with a steel roof and part brick/ part steel clad elevations on a secure site with gated access.

The ground floor accommodation consists of a reception/entrance lobby, with a stairwell offering access to the first floor, along with WC facilities and access to the warehouse area. There is an electric loading door on the southern elevation providing access to the loading and parking areas.

The first floor benefits from mainly open plan office space, but also an office area currently used as a boardroom. There is also a WC and kitchen/breakout area. There is an additional staircase from the first floor offices providing direct access to the warehouse area.

The plot size is 0.338 acres (0.139 hectares) and access to the unit is via Painter Close.
