Location...

The thriving market town of Boston has a population of 68,000 residents and is 115 miles to the north of London on the South Lincolnshire Fens.

Nottingham is 45 miles to the west, King's Lynn 30 miles to the east, Peterborough 35 miles to the south-west and the County City of Lincoln 35 miles to the north.

The site is located on the edge of Boston's main motor trade area on the main vehicular entrance to the site at the top of Sleaford Road on the Boardsides.

Boston Aerodrome is to the west, a new self-store building is immediately to the east. The Princess Royal Sports Stadium, Rugby Club, and Athletics Track is located to the north. Former Crystal Motors Showroom, Mercedes, BMW and Mini Showrooms are to the east with Endeavour Way Business Park nearby.

Tesco, B&Q and Lidl are also located nearby.

Accommodation...

The unit comprises a former showroom which is open plan in nature with offices and ancillary accommodation.

To the western side of the property is a gravelled area for vehicle display spaces along the western boundary.
