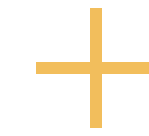

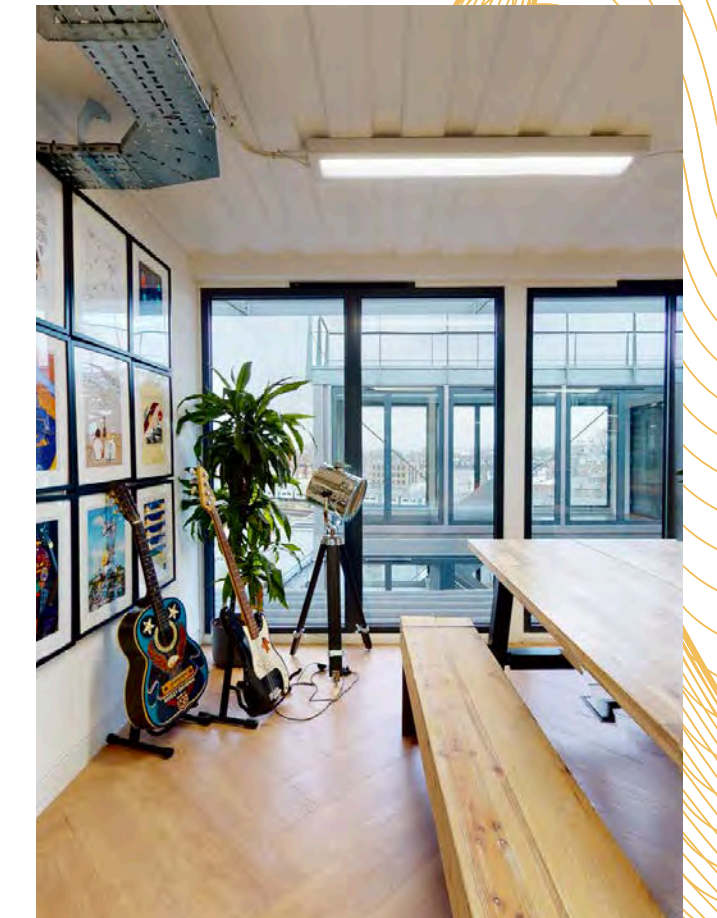
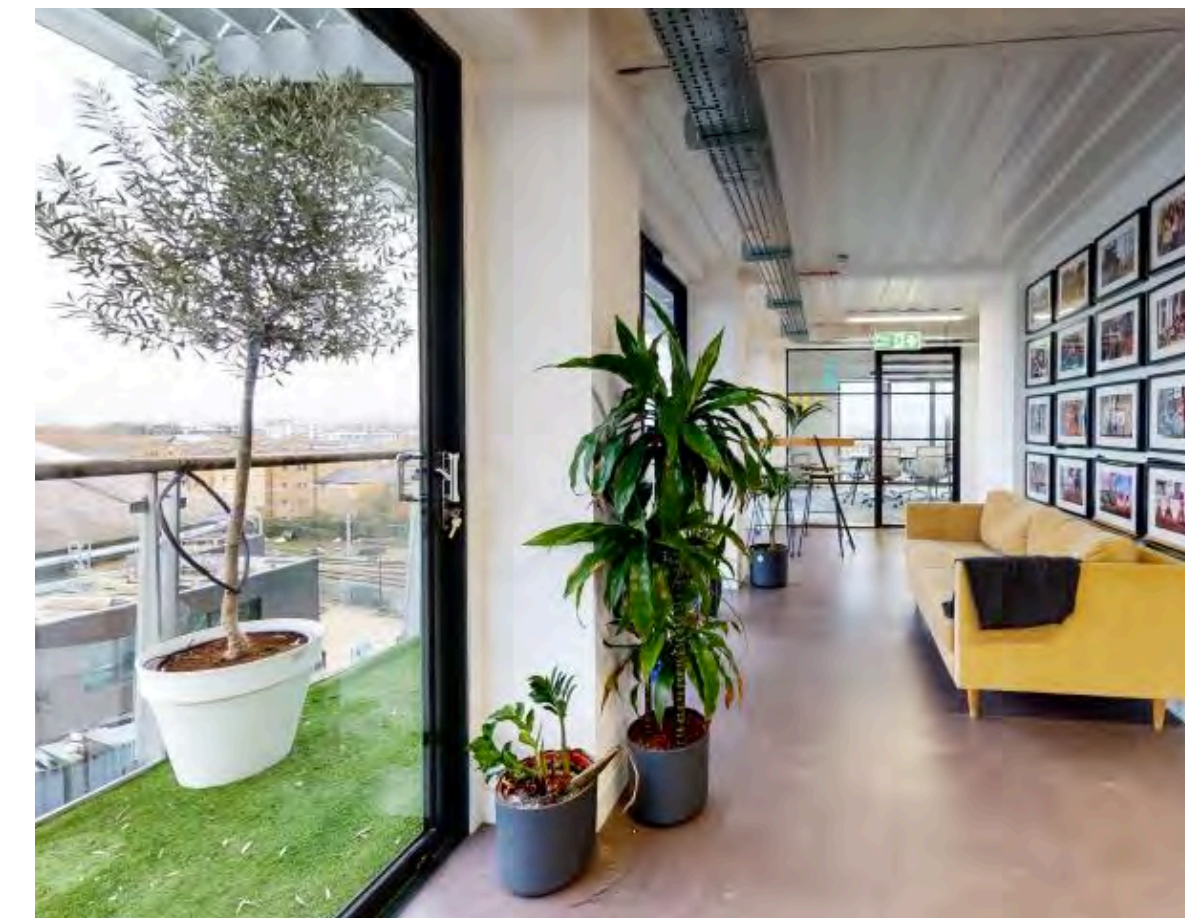
Description

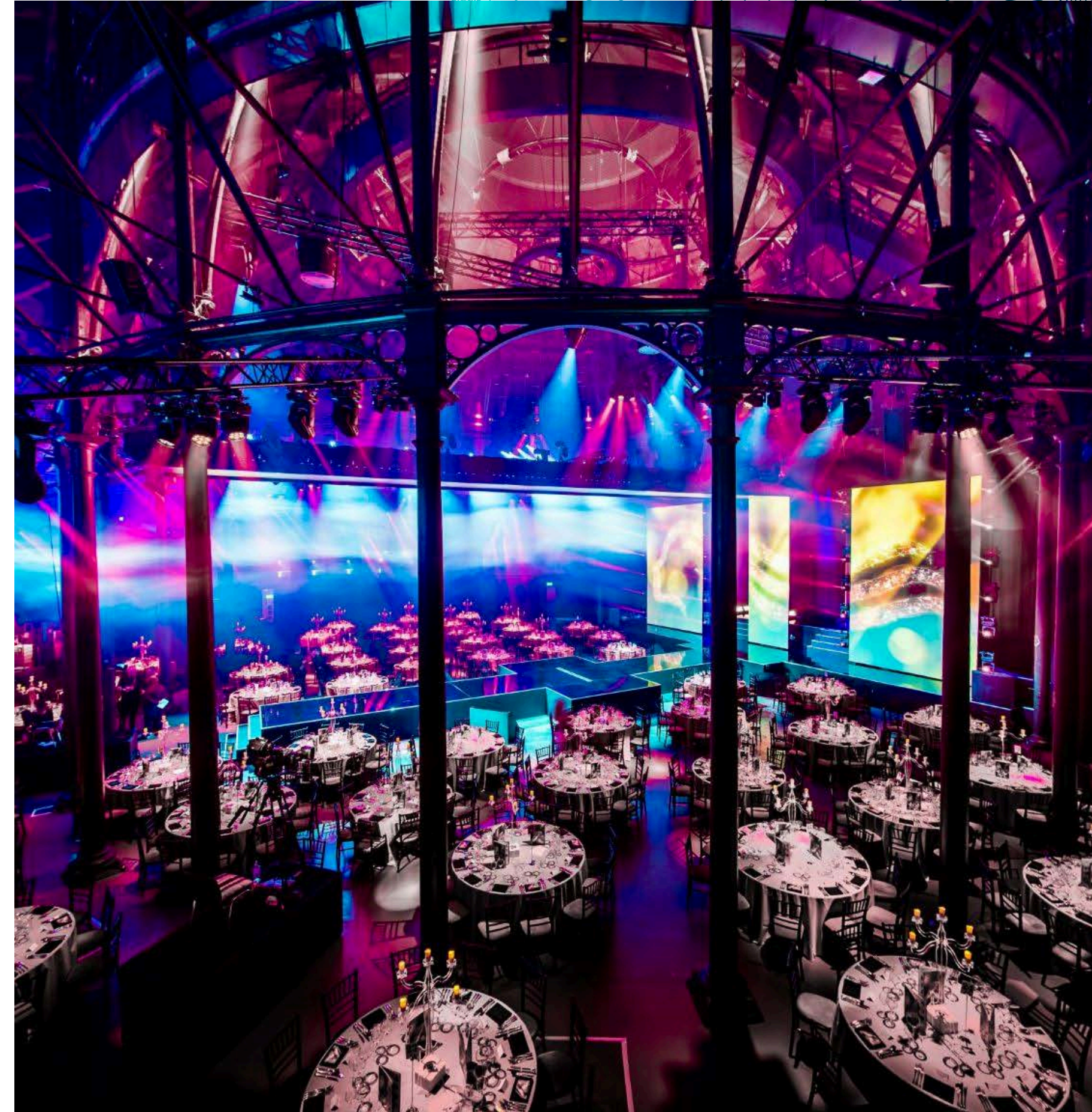
