DESCRIPTION A block of Grade 1 Arable Land extending to approximately 52.07 Acres (21.07 Hectares) located off Franks Lane. The land is divided into 3 parcels individually accessed off a well maintained concrete track. The land can be identified by using OS grid references TF4315 8340, TF4315 6655 and TF4315 6921.

ACCESS The land is accessed directly off Franks Lane.

LAND AND SOIL CLASSIFICATION The land is classified as Grade 1 on the Agricultural Land Classification Map of England and Wales. The soil is shown on the Soil Survey of England & Wales (Sheet 4 - Soils of Eastern England) as belonging to the Newchurch/ Agney Soil Associations which is described as calcareous alluvial gley soils. This soil is deemed suitable for a wide variety of arable and horticultural crops.

BASIC PAYMENT SCHEME The land is registered with the Rural Payments Agency. Subsidy claims are delinked from the land from 2024 onwards.

6.989 Hectares of the land is currently in Mid-Tier Stewardship, which expires on 31st December 2026. The purchaser will be required to take over the scheme and indemnify the seller for any penalties incurred as a result of actions by the purchaser. OUTGOINGS The land falls within the boundaries of the North Level District Internal Drainage Board, therefore drainage rates are payable. For 2023/24 these are £524.09.

SPORTING RIGHTS Sporting Rights are included in the sale.

MINERALS Mineral Rights, in so far as they are owned, are included in the sale.


