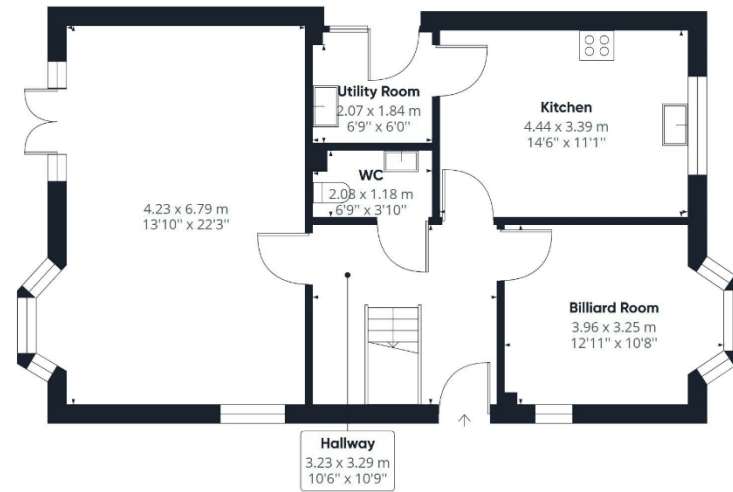
To the rear of the property is a double garage and an added benefit the property is to be offered with no upper chain.



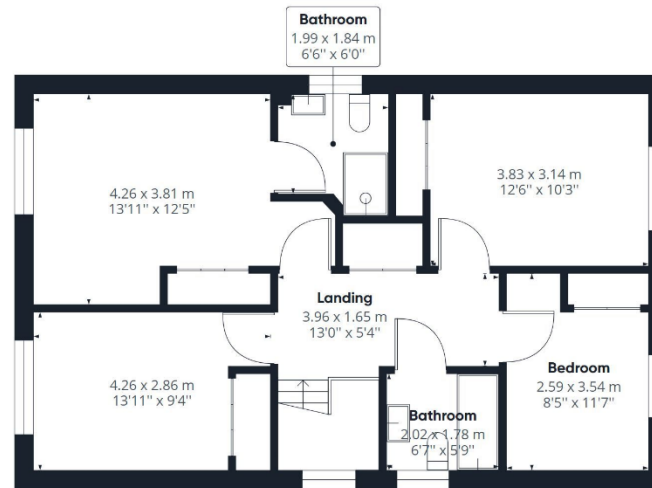

One of Rickmansworth's most popular destinations is the 41 hectares of Local Nature Reserve The Aquadrome, with Lakes, woodland, children's play area and the popular Café in the Park. There are plenty of leisure facilities within the area including an array of golf courses, health clubs and swimming pools.

There are multitude of local shops in Rickmansworth including smaller boutiques and larger High Street chains such as Marks & Spencer, WHSmiths, Boots and a large Waitrose. Restaurants such as Zaza's and Masala Bowl are available as well as gastro pub dining including the Feathers which will offer a more traditional menu. For further retail therapy, the Watford Atria shopping centre is 15 minutes by car.
