Description

Location

Chaucer House occupies a prominent location on Isambard Brunel Road, in the City Centre of Portsmouth.



The property is located across from Portsmouth and Southsea Railway Station, adjacent to the Councils Civic Offices and a short distance to the Guildhall Square, University faculty buildings, Public Library and Premier Inn and the Magistrates Court.
