LOCATION

The unit is situated on Evolution, a business park constructed in 2008 on Lymedale Business Park and accessed from Hooters Hall Road. Hooters Hall Road provides connection to the wider Lymedale Business Park and the A34 dual carriageway (0.8miles). The A34 links to the A500 dual carriageway and the M6 motorway Junctions 15 (6.7miles) & 16 (4.8miles).

Newcastle-under-Lyme Town Centre is located approximately 2 miles from the property.

DESCRIPTION

The property is of portal frame construction with clad elevations. The unit is split 50/50 between ground floor warehouse accommodation and first floor office space.

The ground floor warehouse space has a working height of 3m, loading access via an electric roller shutter door, goods lift, fluorescent strip lighting and a glazed entrance with WCs.

The first floor office accommodation offers an open plan area with two partitioned offices, carpeted floors, suspended ceiling incorporating recessed lighting and a kitchen.

7 parking allocation are provided externally.

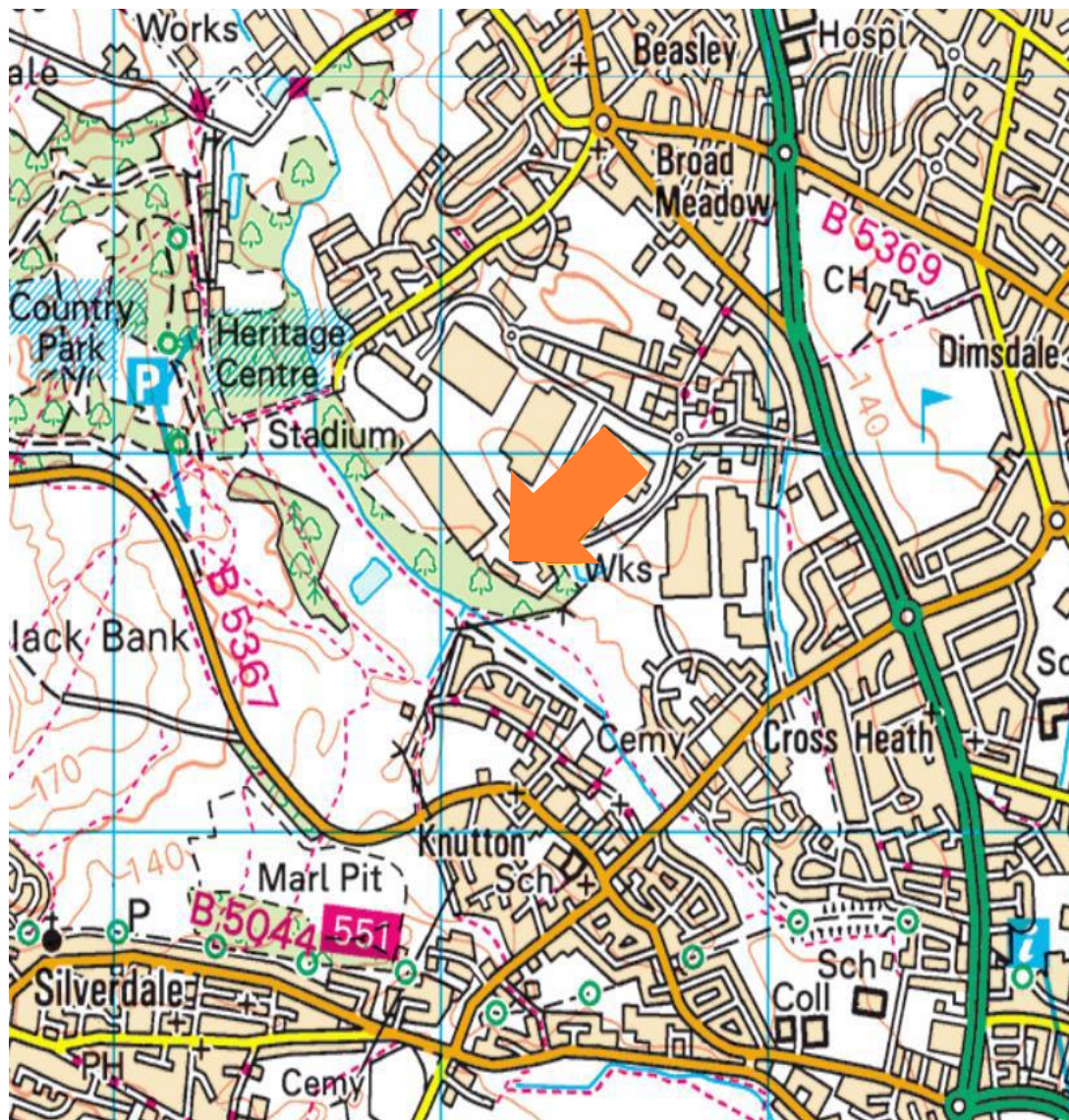
