Planning Consent

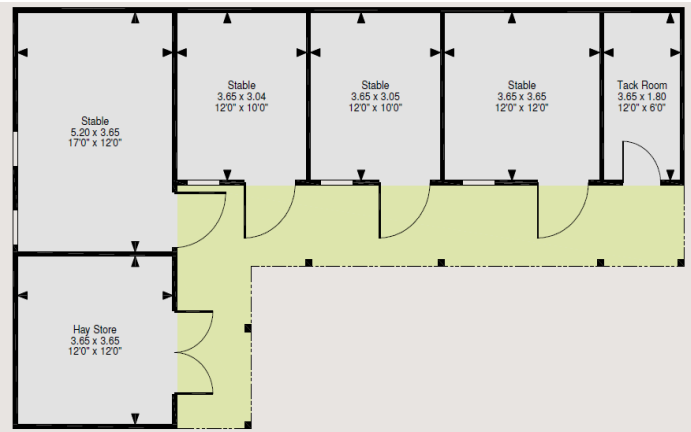
The stables were constructed under planning consent from West Berks DC Ref 13/00514/FUL. There are various conditions to that consent which include:

Limiting the number of horses stabled on site at any one time to four.

The stables shall only be used for private recreational equestrian purposes and shall not be used for any other purpose including commercial riding breeding training or liveryes.

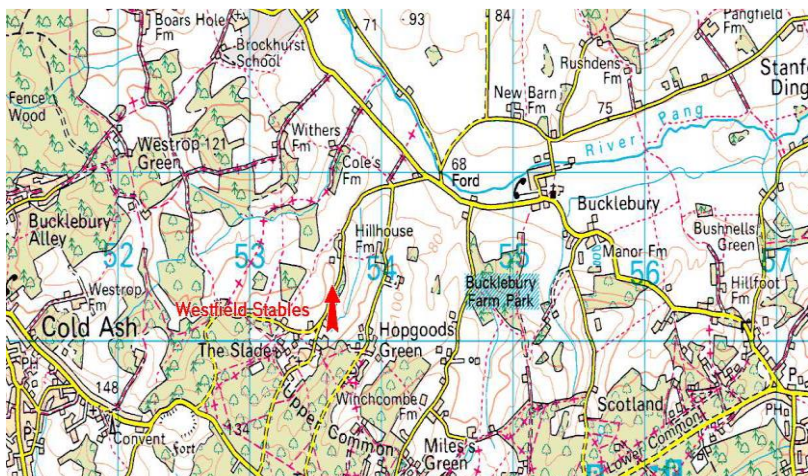
No external lighting of the areas around the stabling
