We are delighted to offer for sale this 60 foot widebeam narrowboat, having been built in 2020 for the present owner to an extremely high and proficient standard. Upon entering from the covered cockpit, there is a luxury fitted kitchen which is open plan to a very comfortable lounge with solid fuel burning stove. The master bedroom with plenty of wardrobe and storage space also has a concealed, electronically operated TV at the foot of the bed. The second bedroom also has wardrobe and large under bed storage and there is an excellent shared shower room. The sale comes complete with a Pied a Terre mooring which is agreed separately with the marina. The location of the mooring within the marina has use of a large lawned area in a very quiet and private area. There is a timber built BBQ lodge with seating for 12 people around the internal fire pit/BBQ making for a superb evening setting.

This is a fantastic boat to cruise in for weeks at a time. Ash timber detailing to give a high quality and bright interior, with a barrelled ceiling and recessed lighting. Self sufficient cruising with Inverter system 240v. Stand alone diesel central heating to radiators. Hot water by heating /engine and immersion when on shore power. Battery charging system. Vetus 12v Bow Thruster. Double glazed aluminum silver windows. Solid Fuel stove (Morso) and TV .

Fabulous fully fitted Galley including double oven, separate under work top fridge and freezer, 4 ring gas hob, marble work tops, microwave and integrated washer dryer washing machine .

The vessel has onboard fresh water storage tanks holding 235 litres and blackwater capability of 210 litres. The vessel has centre cleats and a de-lux cockpit fit out with seating areas fully upholstered. Canal Line 4-cylinder marine diesel engine with plenty of power, yet very economical. Full instrumentation.

- Victron Multiplus 120 amp inverter/charger capable of keeping all the batteries in a good state of charge when connected to 240 volt shore power

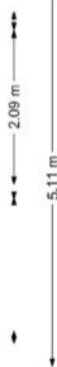
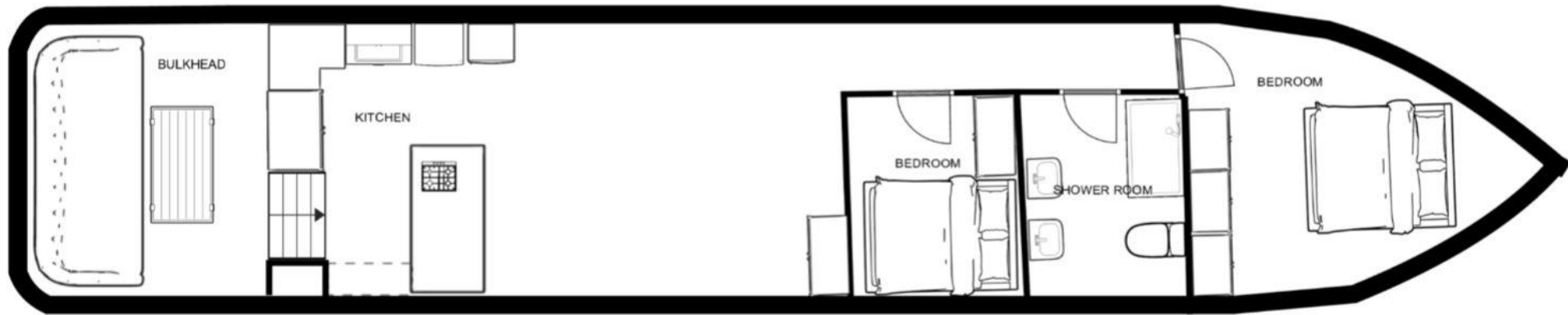
