Unit 12 Huntley Business Park

Modern industrial/warehouse situated within Huntley Business Park, with direct access to the A40.

Location

The property is located in Huntley just off The A40 Gloucester to Ross-on-Wye trunk road, the site is accessed off the A40. Huntley is located to the north of the Forest of Dean approximately 7 miles west from Gloucester, 8 miles southeast from Ross-on-Wye/M50 motorway and 8 miles north-east of Cinderford.

Description

Unit 12 is an industrial/warehouse unit of steel portal frame construction and the elevations are a combination of brick and profile metal cladding with a fully cladded roof incorporating translucent panels at regular intervals.

The accommodation is set out over 2 floors and used as offices and a workshop. A new fitted kitchen and disabled WC are provided at ground floor level. The unit has powder coated concrete floors at ground and first floor level with plastic composite flooring within the ground floor corridor, kitchen and WC areas.

The premises also have powder coated double glazed aluminium windows and doors.

The unit benefits from a vehicular loading door, and internally has LED lighting throughout plus a 3-phase electricity supply.
