The Property: Originally 2 cottages, this stunning period home has retained some great character features including feature fireplaces and cosy wood burner. This contrasts wonderfully with the modern touches such as the fitted kitchen, double glazing throughout, heating via an air source heat pump and French doors in to the garden. Ground floor comprises a sitting room extending to 28', large family kitchen, handy utility, we and underfloor heating. Four bedrooms, bathroom and ensuite off landing.

Outside: Love Cottage is placed near the centre of its glorious plot well established with mature trees and shrubs. There is a patio area to the rear of the property and a large shed outbuilding. Parking for several vehicles.

Services: Mains electricity, water and drainage. Heating is via an air source heat pump.
