INTRODUCTION

No' 17 High Street is conveniently located within the heart of the main shopping thoroughfare of the Galloway town of Dalbeattie. The premises comprises of a licensed café which at present is set up for seating of up to 20, a retail section which retails mostly locally produced products and to the rear exists a traditional stone-built barn, which could have some development potential. **The shop comes fully equipped and benefits from all utilities required to run a successful catering business such as a serving counter, fridges, coffee machines, etc.**, all purchased new within the last five years. The shop has a modern CCTV system and a fully fitted alarm system throughout the premises which can also be linked to mobile phones if required. The property is such that it could easily be changed to accommodate many different types of businesses or indeed as an investment opportunity for an investor, as it is currently a turnkey business that could be easily rented out to provide a good return.

A range of local services can be found within Dalbeattie, with a relatively new school providing education from nursery to secondary. The town also boasts a wide range of retail and professional services, along with a medical centre and leisure facilities. The regional centre of Dumfries, only a 20-minute drive from Dalbeattie.

This area is a popular tourist destination lying within close proximity to the communities of Colvend, Sandyhills, Rockcliffe and Kippford. There are many artists and crafts people within the area with the well-known artist town of Kirkcudbright within easy driving distance. Kippford, affectionately known as 'The Scottish Riviera', is a popular tourist destination and particularly popular with yachtsmen utilising its safe anchorage at the marina.

The region is well-known for the quality and variety of both field sports and leisure activities with the outdoor and sporting enthusiast extremely well-catered for as there exist the ability to take both shooting and fishing locally. Dalbeattie Forest benefits from one of the 7stanes world-class mountain biking trails, making it the ideal location for enthusiastic mountain bikers. In addition, there are golf courses at Dalbeattie, Sandyhills, Kippford and the championship course at Southerness is situated just along the coast.

Communications to the area are much improved with the A75 trunk road providing quick access from the south via the M6 & M74. The ferry links to Northern Ireland run from Cairnryan at Stranraer with the international airports of Prestwick and Glasgow just within an easy drive from the property.

This area of Southwest Scotland enjoys one of the most varied and picturesque landscapes within Scotland, ranging from the moorland of the Southern Upland Hills to the bays and sandy beaches of the distinctive coastline. This is a rural county where agriculture and tourism thrive to form the backbone of the local economy. The area has been relatively unscathed by modern industry.

PARTICULARS OF SALE

No' 17 High Street is of traditional granite construction set over a single floor, briefly comprising:

Primary Shop Floor

With the entrance from the High Street, the main shop floor is a bright room with two large windows to the front. Currently there is seating for up to 20 with a serving counter and a fully equipped kitchen.

Retail Sales Floor

Accessed through the main shop floor to the right, this area is set aside for the sale of mostly locally produced products.

Kitchen

A fully equipped catering kitchen providing all the appliances required to run a successful café.

Rear Hallway

With two WC's off, walk-in storage cupboard and door to the rear courtyard which gives access to the traditional bothy.

Stone Built Barn

The bothy is situated to the rear of the retail unit and currently provides a useful storage space.
