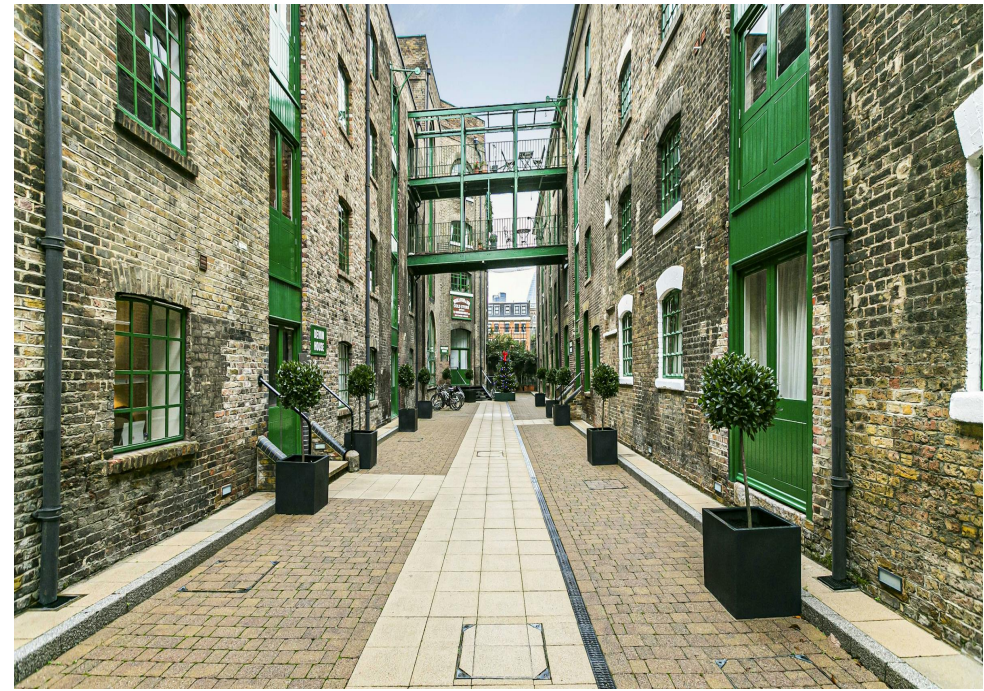
## Location
