Description

This self-contained office situated on the first floor of a converted Victorian warehouse building, has an abundance of character including original sash windows, timbers floors and excellent floor to ceiling heights. The floor benefits from an open plan layout, with two glazed meeting rooms, kitchenette and air conditioning

Location

Zetland House is a unique and striking property, situated in the heart of Shoreditch. The building was originally a Print Works for The Bank of England printing banknotes, stamps and bonds. In the early 00's it was a home for street artist and screen printer Banksy. Located a short walk from Old Street station (Northern line) and Shoreditch High Street station (London overground), and with both Moorgate and Liverpool Street stations under a 10 minute walk away (providing further access to Northern, Circle, Metropolitan and Hammersmith & City lines, as well as National Rail services).

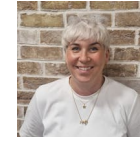
