Description

This is an ideal opportunity to secure a rare freehold building in the heart of Stoke Newington. The building is configured as a vacant ground floor and basement retail unit plus two upper floors. Please note, the two upper floor flats have been sold off and the sale is subject to the benefit of 2 x Ground Rents (Ground Rent of £150 pa each - a total of £300 per annum)

Commercial unit details include an attractive, bright, open plan unit arranged over ground floor and basement which also benefits from an attractive rear garden/outdoor space. The commercial unit floor areas are divided as follows: Ground floor 1,397 square foot and basement 888 square foot, totalling a gross internal space of 2,285 square foot. The external area provides a further 561 square foot of space. The commercial space also offers a fully fitted kitchen to the rear of the ground floor as well as WCs on each floor.

Property benefits from gas supply, 3 phase electricity supply, basement with full sound proofing and sump pump and fitted with both burglar and fire alarms.

The commercial unit is currently being advertised on the market at a rent of £49,995 per annum (February 2024)
