



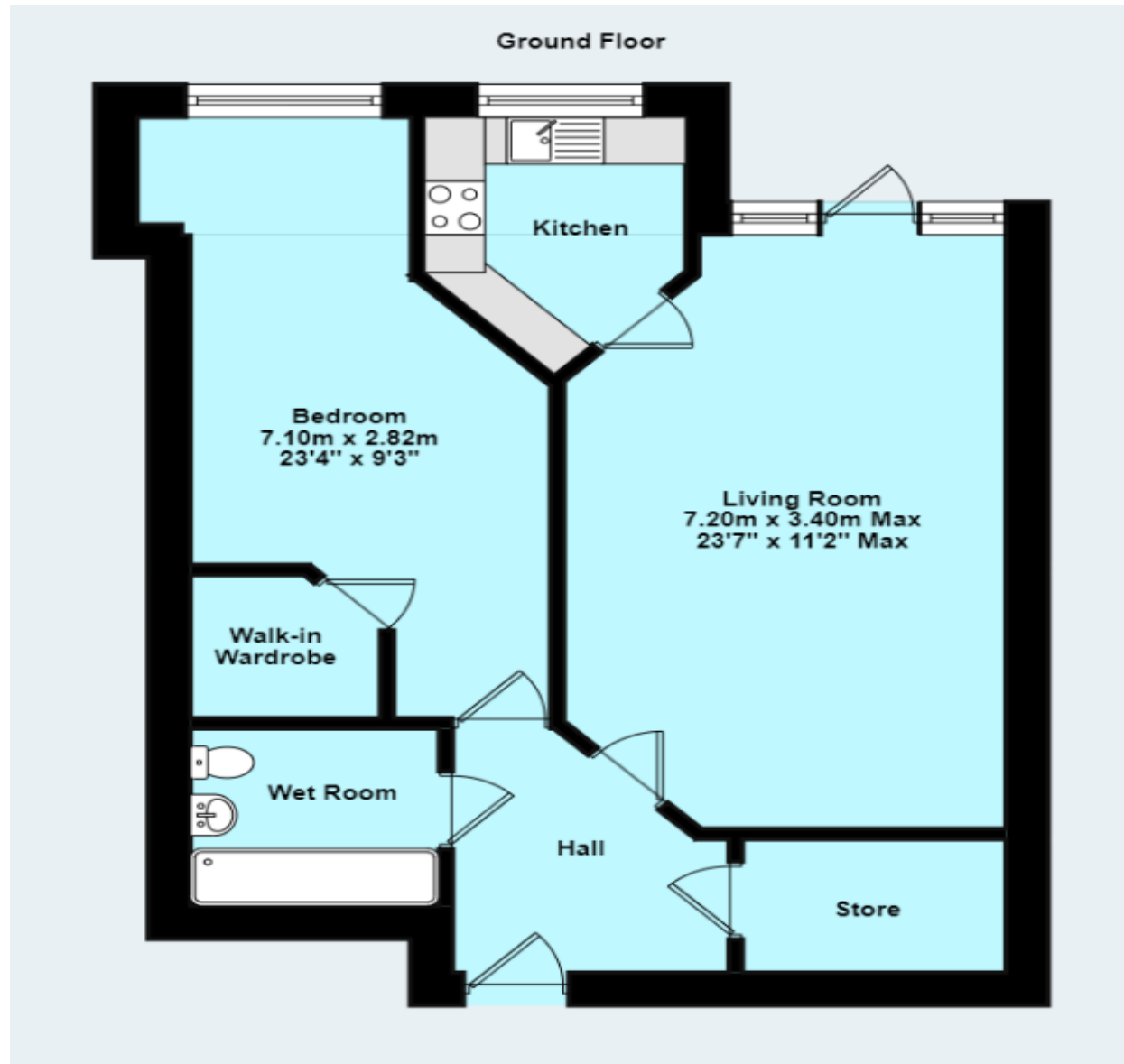

Description

THE ACCOMMODATION COMPRISES IN BRIEF: ENTRANCE HALL with wall mounted entry system, pull cord alarm system and door to a large storage cupboard which houses a pressurized hot water tank, wall mounted water and heating panel and wall mounted fuse board.

LIVING ROOM: which has a door with windows on either side leading to a small patio area. A glazed door also leads to the,

KITCHEN: fitted with a range of modern wall and base units, stainless steel sink and drainer incorporated into work surface, integrated induction hob with stainless steel extractor hood over, eye level oven, integrated fridge and freezer, tiled floor and a window to the front.

BEDROOM: with window to the front and large walk-in wardrobe with fitted shelving and hanging space.

WET ROOM: with tiled walls and floor, large shower cubicle with glazed shower screen, vanity unit wash hand basin, low level wc and heated towel rail.
