






Approached via a deep driveway to the front the home is entered via an endoxed porch which gives access to a large hallway, a formal dring room to the front, an elegant lounge to the rear overlooks the neatly landscaped and private garden, a fitted kitchen and breakfast room with a utility room off, the main bedroom has a dressing area and en suite bathroom, bedrooms two and three share a family bathroom and to complete the home there is a detached double garage.

FORMAL DINING ROOM 14' 10" x 12' 10" (452m x 3.91m) A great space for entertaining with two front fading windows, a further window to the side allowing natural light, coving, radiator, a door in to the kitchen diner and double doors leading in to the formal lounge.
