The property occupies a prominent corner position at the junction of Queen Street and Halkett Street in the Parish of St Helier. More specifically the property is located to the centre of Queen Street on its northern side opposite Boots the Chemist on one elevation, and Molton Brown on the corresponding elevation, and is highly visible from both Queen Street and Halkett Street respectively. There are public car parking facilities within a short walking distance within Minden Place, Snow Hill and Green Street car parks.

The building is called Orviss House and is located on the western side of Halkett Street. The property comprises a fully self-contained, mid terraced, 3 storey building providing retail space on the ground floor two floors of self-contained offices above. The retail unit is accessed from Halkett Place and the offices are accessed from their own dedicated entrance to the rear.
