Location


The industrial/warehouse unit is situated on a modern Industrial Park located off Bidder Street in Canning Town being three miles east of the City of London. The unit benefits from easy access to the A13 for Docklands, the City and Central London which also links to the A12/A102 (Blackwall Tunnel Northern Approach), the North Circular Road (A406) and M25 Motorway for access to the National Motorway network.

The Industrial Park also benefits from good public transport links with Star Lane Station (DLR Line) only 0.1 miles away and Canning Town Underground Station (DLR & Jubilee Line) within half a mile. Canary Wharf, City Airport and Excel Exhibition are in close proximity to the Park.
