ACCOMMODATION

Ground Floor:

Covered Entrance leads to Entrance Hallway leading to; Cloakroom, well appointed modern Kitchen/Breakfast Room with a range of wall and base level cupboards for storage, and a spacious Reception Room with open fireplace to the rear of the property overlooking the low maintenance Garden. The entrance Hallway also provides internal access to the Garage.

First Floor:

Stairs from the Entrance Hall lead to the first floor landing, in turn leading to Master Bedroom with modern En Suite Shower Room and fitted wardrobes, 2 further Double Bedrooms of which one has built in wardrobes, Bedroom 4 and a Family Bathroom.

Exterior:

To the front of the property there is a brick paved drive way allowing for Off Road Parking for 2 cars and access to the Garage. To the rear of the property there is a good size westerly facing garden, mainly laid to lawn with a patio area immediately outside the Living Room.



SITUATION

The property is situated in the centre of this popular Sussex village within easy walking distance of the local shops, post office, primary school and public houses. Crowborough, with its good range of supermarkets including Wai trose and Morrison's and Jarvis Brook mainline railway station with a direct service to London Bridge are about 3 miles away. Tunbridge Wells is about 7.5 miles where there are comprehensive shopping facilities and amenities, recreational sports centres, cinema complex, theatres, golf courses and numerous restaurants etc. and a mainline railway station with a direct service to London Street.
