The accommodation includes private front door to an entrance hall with meter/storage cupboard and stairs rising to the first floor landing with hatch to loft space, a cloaks cupboard and a storage cupboard.

A particular feature is the generous dual aspect kitchen/living/dining room with recently installed mood lighting. The kitchen is fitted with a range of white cupboards complemented by a built in table with seating for 6 people. Integrated appliances include a gas hob, an oven, a dishwasher, a washing machine and a fridge/freezer.

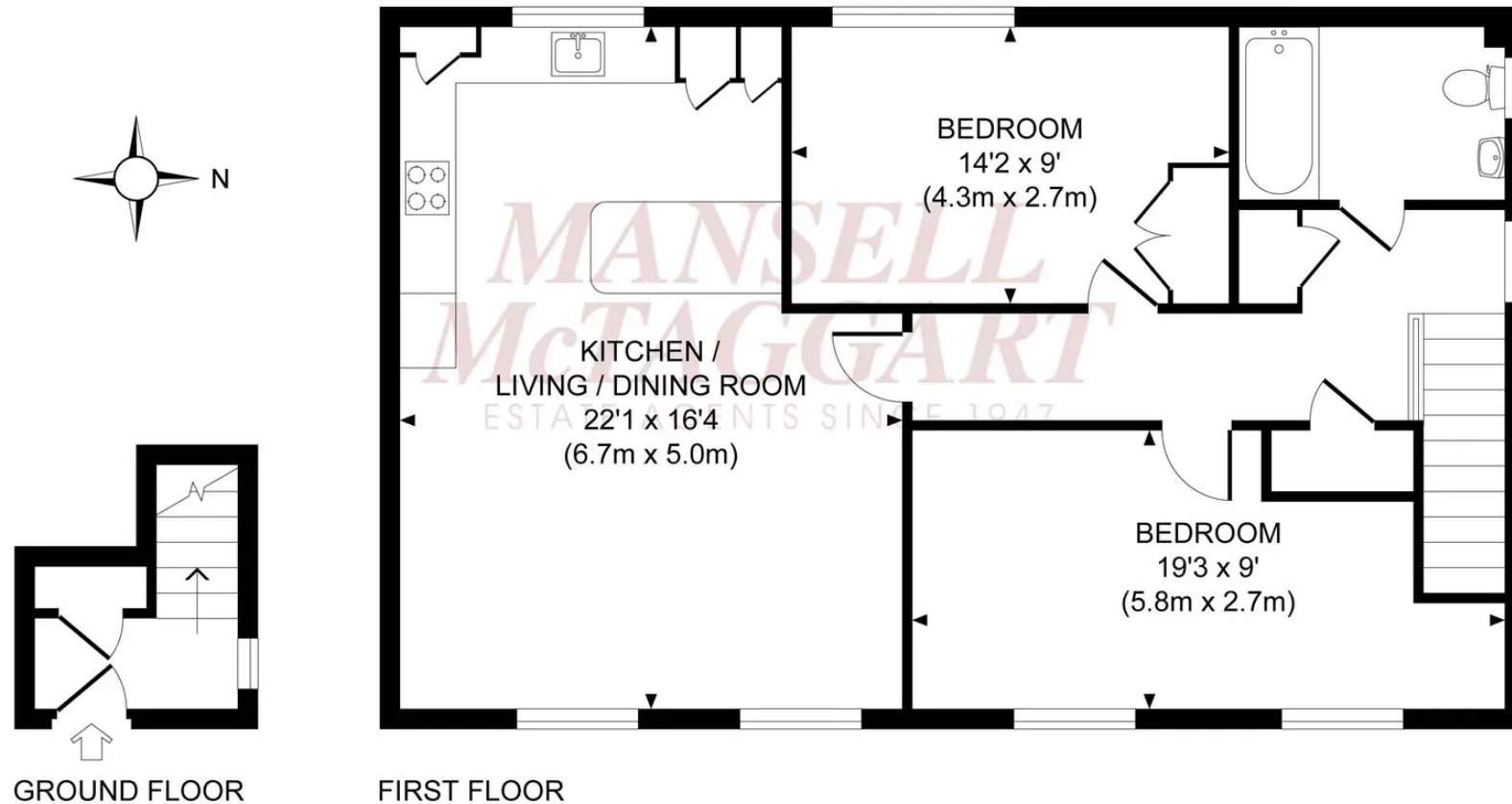
There are 2 large double bedrooms and a bathroom fitted with a white suite.
