

Situated in a popular cul-de-sac is this two bedroomed semi-detached bungalow featuring a separate dining room plus a conservatory overlooking low maintenance landscaped gardens. Further benefits include a 66ft driveway providing off road parking for numerous cars, a single garage with remote control electric door, uPVC double glazing and gas warm air heating. The accommodation briefly comprises entrance hall, lounge, dining room, kitchen, two bedrooms, shower room, conservatory, gardens to front and rear, garage and driveway.
