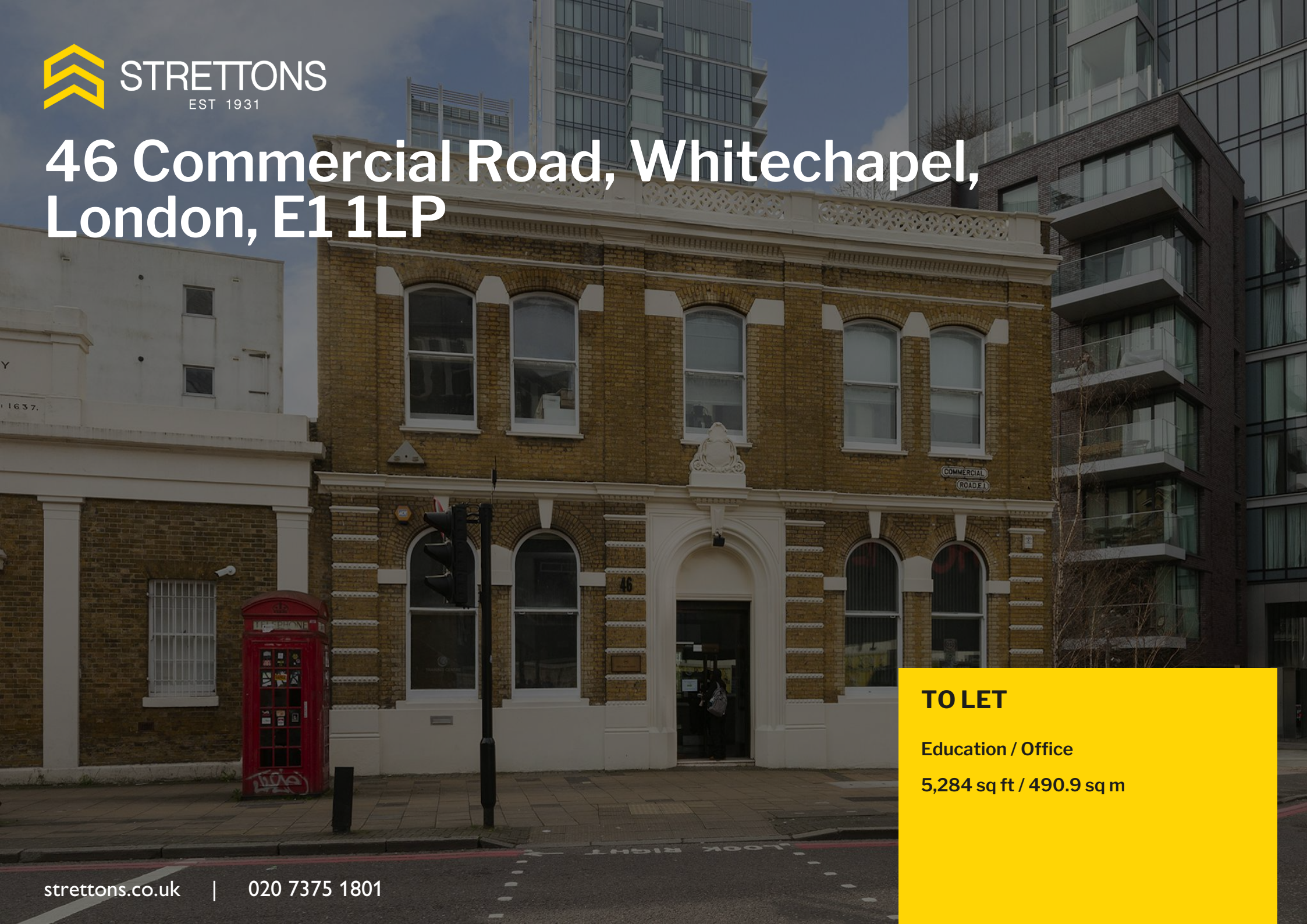

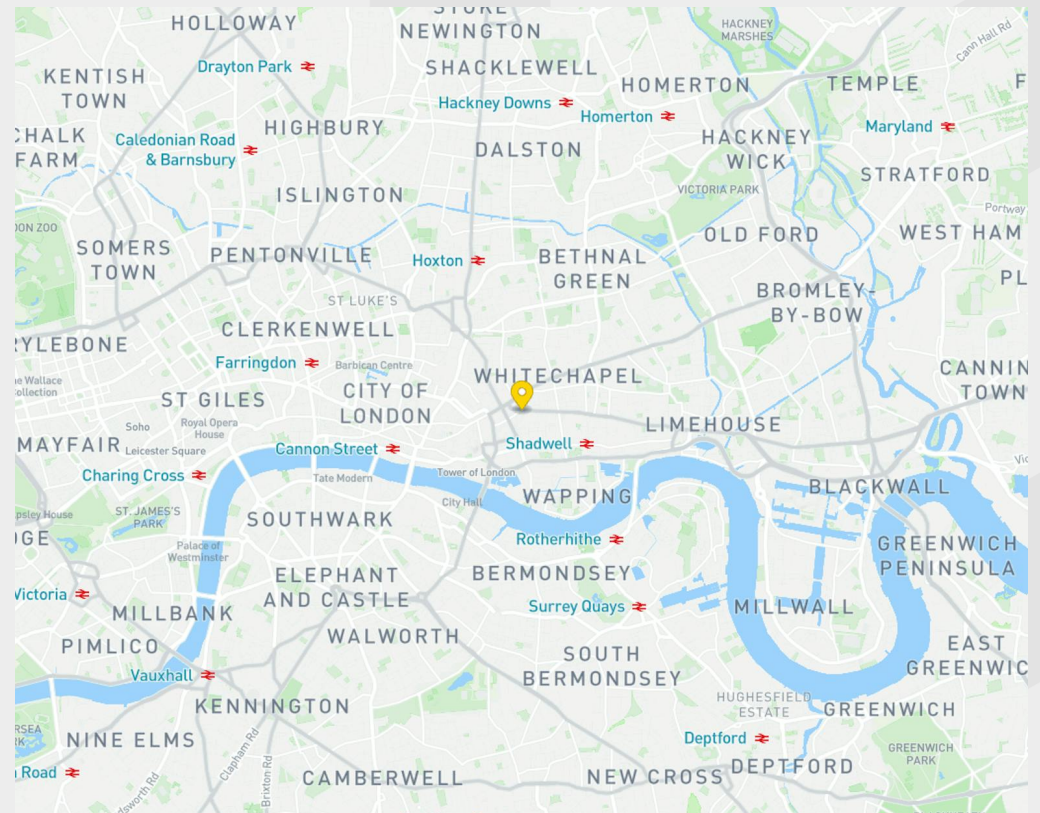


Description

46 Commercial Road is a unique Grade II Listed character building. It is entirely self-contained and arranged over lower ground, ground, and first floors. The property has very prominent frontage onto Commercial Road as well as a private/ secure rear yard. The building benefits from existing and rarely found F1 planning consent but could suit alternative uses subject to planning.

Location

The area is well-served by public transport. Aldgate East (Hammersmith & City & District) is a 6-minute walk west. Whitechapel (Hammersmith & City, District, Elizabeth and Overground) and Liverpool Street (Central, Circle, Hammersmith & City, Metropolitan, Elizabeth and Railway) are within 0.6 miles. The building is a 4-minute walk from Goodman's Fields, offering restaurants, fitness facilities, shops, entertainment and green space.
